Program Scope + Overview



Free for Rhode Island-based residents, students, companies, and employees.

The Med Tech Leadership Program is designed to teach the best commercialization practices for regulated medical technologies. Example topics include medical device regulations, current industry trends, intellectual property, developing an investable business, raising capital, and more.

The Program consists of 50+ hours of classes and workshops over the span of 6 months. Programming will be held in person expect sessions taught by out-of-state advisors. In addition to educational sessions, participants will receive 2-5 hours of free mentoring with NEMIC Staff and Advisors throughout the duration of the program. Participants will translate their business idea and technology into an investable pitch deck. Those without their own idea can develop from a NEMIC case study.

The curriculum was created based on firsthand research interviews with industry professionals, CEOs, venture capitalists, angel investors, and seasoned Med Tech entrepreneurs. Read more about our curriculum research here: <u>bit.ly/3R2omKF</u>
